Call to Order 6:05 pm by SEAC chair, Betsey Soulsby
Welcome and self-introductions were made

Presentation Brian Gordon – Madison County Sheriff Department
John Sherer – Madison County EMS
Discussion of Louisa County initiative for First Responder Alert System, detailed form which includes medical conditions, cognitive ability, comforts, fears, current picture and must be updated yearly (birthday month suggested). Stickers for car and house windows and seat belt cover alerts are available.
Madison County's concern about HIPPA issues with sensitive information stated over the radio system which the general public can access. Sheriff would need to make the decision on participating with the initiative.
Mr. Sherer stated if EMS called to school it is very helpful to have teacher with the student to help reassure and prompt cooperation with EMS.
Mr. Sherer expressed concern about stickers left on windows after person with the disability has moved which can lead to First Responders risking themselves looking for a person no longer living in the house.
EMS and Sheriff Department would be interested in collaborating to have a First Responder Awareness meet and greet
